Audiology Au.D.

Audiologists provide comprehensive diagnostic and rehabilitative services for all areas of auditory, vestibular, and related disorders.

These services are provided to individuals

- across the entire age span from birth through adulthood;
- from diverse language, ethnic, cultural, and socioeconomic backgrounds; and
- who may have multiple disabilities.

Program Description

The Doctor of Audiology (AuD) degree provides an academic and clinical foundation for professionals providing services to children and adults with hearing impairments and qualifies graduates for certification and licensure in the profession of audiology.

Graduates of the AuD program meet all requirements of the American Speech-Language-Hearing Association's Certificate of Clinical Competence (CCC) and state licensure.

Admission Requirements

Applicants are required to complete application through CSDCAS <u>and</u> a supplemental application through OUHSC. Your application will not be considered unless both applications are complete and application fees are paid.

To be considered for admission to the AuD program, the applicant must complete the following requirements:

Complete a bachelor's degree from an accredited college or university in Communication Sciences and Disorders (CSD) or another field. If the baccalaureate degree is in a field other than speech/hearing, then the applicant may apply for lateral entry into the Doctor of Audiology (AuD) program. If admitted, then lateral entry students are subsequently

enrolled in 24 semester hours of leveling coursework in CSD;

- Have a minimum 3.0 cumulative GPA on the last 60 hours of undergraduate coursework or the last 12 hours of graded graduate coursework (please note: in calculating GPA, the entire semester in which the 60or 12-hours fall is counted). The College of Allied Health does not recognize academic forgiveness or reprieve policies. All attempts of a course are included in the calculation of GPAs;
- Submit official transcripts from all colleges and/or universities attended and nonrefundable application fees;
- Submit Graduate Record Examination (GRE) scores (the General Test) before the application deadline date. GRE scores must be no more than five years old at the time of application. The CSDCAS OUHSC institution code for the GRE is 3549;
- Three evaluations (also called letters of recommendation) communicating the abilities of the applicant's success in graduate school submitted through CSDCAS application;
- Complete a zoom interview with the CSD admissions committee at the program's discretion;
- Students for whom English is a second language must earn a minimum score of 600 (paper-based) or 100 (internet-based) within two years prior to application on the Test of English as a Foreign Language (TOEFL). The CSDCAS OUHSC institution code for the TOEFL is C122;

- All international/Non-US Citizen applicants are required to have all transcripts/mark sheets from foreign institutions evaluated by World Education Services (WES) or Educational Credential Evaluators (ECE); and
- Submit completed online applications. The application deadline is February 1 for all applicants to the AuD program.

Admission Prerequisites

While there are no prerequisites to join the program, it is recommended that applicants complete course work in 1) Biology, 2) Physics or Chemistry, 3) Behavioral or Social Science, and 4) Statistics either before beginning the graduate curriculum or during the first year of this professional degree program. These courses both support the successful completion of graduate coursework and are required for national certification as an audiologist.

Application Procedure

- Fully complete a CSDCAS application and OUHSC supplemental application by the February 1st deadline
- Completed applications will be reviewed immediately after the deadline. Selected students will receive an invitation for a zoom interview.
- An electronic letter of acceptance, alternate status, or denial to the program will be made in March. If notification is not received by May 1, please contact the department.
- Students accepted for admission to the AuD program are required to confirm their intention to enroll by paying a nonrefundable deposit on enrollment. The deposit is applied toward tuition and fees during the first term.

Estimated Program Costs

Students may expect additional costs that include, but are not limited to, a personal computer, textbooks, lab fees, insurance, and supplies.
